



TERMS AND CONDITIONS SUPPLIERS

- ✦ All requests for information by the Supplier, will be answered by the WMF sales team within a maximum period of 48 hours.
- ✦ World Meetings Forum reserves the right of admission of Suppliers according to WMF criteria.
- ✦ In order to participate with the category of Supplier in the WMF you must have the minimum hiring 1 Table Top World Meetings Forum. In addition, the Supplier may acquire sponsors for more visibility within the event.
- ✦ WMF will send you a registration link to the WMF platform in which you must fill in all the information requested as mandatory.
- ✦ Once the Supplier is registered in the platform, you will receive an email confirming your participation.
- ✦ The hiring of each Table Top-World Meetings Forum includes:
 - Agenda for business appointments with qualified Hosted Buyers.
 - 2 full Access accreditations for WMF
 - Company information in the official App of the event
 - Access to all social and networking events
 - Meals included for accredited persons within the framework of the event

- ❖ The supplier must speak English fluently as a universal language, as some hosted buyers are of foreign origin.
- ❖ The Supplier accepts that will not be able to use the Table Top, if he has not covered 100% of the total amount of this contract 30 days before the event.
- ❖ The Supplier agrees to strictly adhere to the provisions of the WMF Operations Regulations.
- ❖ In case of cancellation or reduction of the hired services, a Conventional Penalty will be charged according to the contract signed by the Supplier.
- ❖ The Supplier accepts that WMF maintains its data in accordance with our Privacy Policy and accepts that WMF can communicate with you regarding your request and future news and events.
